# INFORMATION FOR CONTRIBUTORS

The College of The Bahamas Research Journal (ISSN 1607-1069) is a scholarly, peer-reviewed research journal published annually by the College of the Bahamas, P.O. Box N-4912, Nassau, Bahamas. The production of the journal is managed by an Editorial Board, which is a sub-committee of the Research and Publications Committee in the Research Unit, Moss Road.

The major purposes of the journal are to disseminate products of research and academic activity, which are relevant to the College and The Bahamas, and to stimulate participation in such activity by members of the College and the national research community. The journal affords authors the widest possible freedom of expression that is consistent with the integrity of research. Opinions expressed by authors are not necessarily those of the Editorial Board.

The policy of the editorial board is that the journal should present a whole-some mix of articles, based on scientific and sustained analytic enquiry, book or movie reviews of scholarly interest and advocacy papers. While the board wants to attract unpublished and original research on The Bahamas, it welcomes research of regional or comparative interest. Contributions may be in any field of knowledge, but should communicate effectively with readers who are not specialists in the field.

Manuscripts submitted for publication must be original material which is not being considered for publication elsewhere. Following a preliminary editorial review, the manuscripts will be assessed by reviewers, both within and outside the College, whose expertise matches the paper under review.

The papers should be between 1,500 and 5,000 words in length (6-20 pages). Two hard copies and one electronic copy of the manuscript should be submitted on  $8.5 \times 11$  inch paper, double spaced and should follow the guidelines of the Publication Manual of the American Psychological Association, 5th edition, 2002 (see back cover). Single-spaced manuscripts and manuscripts not using APA style (including the bibliography) will be returned to the author. Be sure to avoid any author identification on manuscript pages to facilitate blind review.

On a cover page please include the following: article title, full name of author(s) as meant to appear in print, author's address, telephone, fax and e-mail as well as a short abstract of no more than 200 words and a brief biography.
