Martin Buntun is Associate Professor at the University of Victoria (Canada), where he teaches modern Middle Eastern history and the history of the region in its global context. He is the author of several books, including *The Palestinian-Israeli Conflict: A Very Short Introduction* (Oxford, 2012) and *Land Legislation in Mandate Palestine* (Cambridge, 2010). He is also co-author, with the late William Cleveland, of *A History of the Modern Middle East, 4th Edition* (Westview, 2012). His current research focuses on the evolution of colonial land policies in Egypt in the late 19th and 20th centuries.

Julian Brooks holds a PhD from the Department of History at Simon Fraser University. His doctoral thesis examines the British response to the Macedonian Crises of 1902-03 and Britain's role in the making and execution of the Mürzsteg Reform Program. His research interests include comparative imperialism, nationalism and education, and humanitarian intervention and peacekeeping in the Near East.

Neera Chandhoke is currently National Fellow of the Indian Council of Social Science Research, New Delhi after a long career as professor of political theory at the University of Delhi. She has been a Senior Fellow *Justitia Amplificata*, Goethe University, Frankfurt (2012-2013), Luiss University, Rome, (2011), London School of Economics and Political Science (2007), Shastri-Indo Canadian Foundation (Delhi, 1999), Jawaharlal Nehru Fund, New Delhi (1997-98), and the Nehru Memorial Museum and Library, Teen Murti House, Delhi (1989-1992). She has been president of the Asian Political and International Studies Association (2007). Among her published works are *Contested Secessions* (Oxford U Press, 2013), *The Conceits of Civil Society* (Oxford U Press, 2003), *Beyond Secularism: The Rights of Religious Minorities* (Oxford U Press, 1999) and *State and Civil Society* (Sage, 1995). She has won special awards from the University Grants Commission, Delhi (2010); the Gaetano Mosca Chair, University of Turin (2009), and the Eminent Alumna Award, Lady Shriram College, University of Delhi (2007).

Odysseas Christou is a Lecturer at the Department of European Studies and International Relations and the Department of Law at the University of Nicosia. He holds a PhD (2009) from the University of Texas at Austin. His areas of specialization are international relations, comparative politics, and political violence. He has participated in numerous research projects funded at the European and national levels on issues such as political violence, migration, and comparative international development. His most recent journal publications and conference proceedings focus on processes of securitization with an emphasis on energy security in the European Union and the broader region.

André Gerolymatos is Professor of History and Director of the Stavros Niarchos Foundation Centre for Hellenic Studies at Simon Fraser University. His *Castles Made of Sand: A Century of Anglo-American Espionage and Intervention in the Middle East*, first published in 2010 was issued in Arabic by All Prints Distributors and Publishers of Beirut in 2012. Other recent books include *Red Acropolis Black Terror: The Greek Civil War and the Origins of Soviet-American Rivalry, 1943-1949* and *The Balkans Wars: Conquest Revolution and Retribution from the Ottoman Era to the Twentieth Century and Beyond*.

Christos P. Ioannides is Director of the Center for Byzantine and Modern Greek Studies, Queens College, CUNY. He received his Ph. in International Affairs from the University of Pennsylvania focusing on the Eastern Mediterranean and the Middle East. He has published extensively on the Cyprus dispute, Greek-Turkish relations, Middle Eastern politics and Greek American affairs. His works include *In Turkey's Image: The Transformation of Occupied Cyprus into a Turkish Province*; *Realpolitik in the Eastern Mediterranean: From Kissinger and the Cyprus Crisis to Carter and the Lifting of the Turkish Arms Embargo* and *America's Iran: Injury and Catharsis*. He is the editor of *Greeks in English-speaking Countries, Culture, Identity, Politics*; and *Cyprus: Domestic Dynamics, External Constraints*. He recently completed a book on British colonial rule in Cyprus since Britain succeeded the Ottomans in 1878.

David B. Kanin is a Professorial Lecturer at the School of Advanced International Studies, Johns Hopkins University. In 2010 he retired as a senior analyst after a 31-year career with the Central Intelligence Agency. He was a founding member of the Red Cell, an alternative analysis and brainstorming group. His

responsibilities included challenging Agency judgments and presenting alternative worldviews to senior policymakers. From 2007-2009, Dr. Kanin served as Director of Long-Range Identity Studies on the National Intelligence Council. He was senior political analyst on the Director of Intelligence's Interagency Balkan Task Force during the wars that followed the collapse of former Yugoslavia in the 1990s. From 1993-1996 he was Deputy National Intelligence Officer for Europe. Earlier, Dr. Kanin worked on European security issues, Yugoslavia, and North Korea. He participated in the Madrid Review conference of the Conference on Security and Cooperation in Europe in 1981 and the Rambouillet talks on Kosovo in 1999. Dr. Kanin holds a Ph.D. from the Fletcher School of Law and Diplomacy, Tufts University.

Edward McWhinney is Queen's Counsel; Barrister-at-Law; Barrister and Solicitor; Professor Emeritus of Constitutional and International Law; Member and Past President, *Institut de Droit International*; Member, *Académie Internationale de Droit Comparé*; sometime Member of the Permanent Court of Arbitration; sometime Member of Parliament (Canada), and Parliamentary Secretary, Foreign Affairs.

Andrew Theobald completed his Ph.D. at Queen's University in 2009. His dissertation focused on the United Nations Truce Supervision Organization (UNTSO) and its Middle Eastern peacekeeping activities in 1949-1956. He is the author of *The Bitter Harvest of War: New Brunswick and the Conscription Crisis of 1917*, and his additional publications include articles in *Middle Eastern Studies*, *Ontario History*, and *Acadiensis*, and an essay in the edited collection *Plurality and Citizenship in Israel*. He also wrote the UNTSO entry for the forthcoming *Oxford Handbook on United Nations Peacekeeping Operations*. He currently works as a documentary film researcher.

Andreas Theophanous received his BA in Economics and Political Science at Susquehanna University (1983) and his MA and PhD degrees from Pennsylvania State University in Economics in 1985 and 1988 respectively. He served as Economic Advisor to the Republic of Cyprus from 1990-1993. He is Professor of Political Economy and head of the Department of European Relations at the University of Nicosia, and he is President of the Cyprus Center for European and International relations. His areas of specialization and interest are political

economy, Cyprus-related issues, governance in bi-ethnic and multi-ethnic societies, and EU affairs with an emphasis on issues of integration. He has visited several European, American, and other universities and think tanks as Visiting Professor, Senior Fellow, and/or Guest Speaker. Theophanous is the author and co-editor of several books and numerous articles.
