# Harry J. Psomiades: Pioneering Scholar and Educator 1928–2011

The issue at hand of the *Journal of Modern Hellenism* (JMH) is dedicated to the memory of its founder, Harry J. Psomiades, who passed away on August 13, 2011, at the age of 82. It was Professor Psomiades who, along with Nomikos Vaporis, founded the *JMH* in 1984 and led it until 2002. Under his guidance, the *JMH* emerged as an important scholarly publication with an interdisciplinary approach to the study of the modern Greek world. The scope of the *JMH* covers Greece, Cyprus and their regional environment, as well as the Greek Diaspora with special emphasis on Greek American community dynamics. As such, the *JMH* offers a valuable platform which promotes research and advances knowledge on the phenomenon of modern Hellenism. In this regard, the *JMH* constitutes a lasting legacy of Professor Psomiades.

To this legacy, one must include the other multifaceted contributions of Harry J. Psomiades to the fields of Byzantine and Modern Greek Studies in America. His academic career was characterized by an unrivalled ethos, fairness, and respect for the other point of view, all reflecting the nobility of his spirit. Coming from Columbia University, he founded the Center for Byzantine and Modern Greek Studies at Queens College in 1974. He was Director of the Center for three decades, and during his tenure, with Assistant Director

Effie Lekas as his right hand since 1985, he elevated it to a beacon of Hellenic letters through the teaching and study of Byzantium, modern Greece, Cyprus, and the Greek American community. With regard to Byzantine Studies, Professor Angela Constantinides Hero, a renowned Byzantinist, was a close collaborator of Professor Psomiades over the years. As an academic teacher, he was loved by his students who benefited from his wisdom. As a researcher and author, he covered a wide spectrum of topics, reflecting his vast knowledge of subjects ranging, from Greek politics, to Greek-Turkish relations, to the Ecumenical Patriarchate, to the Cyprus issue, to the Balkans, to the Greek American community. He paid special attention to Asia Minor Hellenism and the Pontos. His parents came from Pontos and he was proud of his Pontian roots.

Throughout his life, through his academic and community activities, Harry Psomiades strived towards achieving the recognition of the Pontian genocide by the United States. His dedication to Asia Minor Hellenism and the plight of the Greek refugees, following the Asia Minor Catastrophe, led him to pursue an ambitious project regarding their story. He was able to bring this project to fruition, but unfortunately, his Fridtjof Nansen and the Greek Refugee Question, 1922-1924 had to be published posthumously. As such, this last book by Professor Psomiades will remain a classic in this field. In this issue, we are publishing a selection from that title.

Given his contributions to Hellenism, we believe it is quite fitting, therefore, to dedicate the present issue of the JMH to the memory of its founder, a giant of Greek paideia in America, Harry I. Psomiades. The contributors to this issue, under the editorial supervision of Dan Georgakas, are academics and diplomats, all colleagues and friends of Professor Psomiades. They are honoring his memory through their writings because scripta manet. Their articles are related to subjects that preoccupied this enlightened scholar during his illustrious career. Below is a synopsis of Harry J. Psomiades' academic career.

## **Educational Accomplishments**

Harry J. Psomiades graduated from the Boston Public Latin School in 1946. He proceeded to Boston University earning an A.B. (Magna cum Laude) in 1953. He went on to Columbia University where he earned an M.I.A in International Affairs in 1955, and a Ph.D. in Public Law and Government in 1962. Subsequently, he received a Diploma from the United States Army War College, Carlyle Barracks, Pennsylvania, 1977. Apropos of his military studies, he served at the US Army as Regular (1946-1950) and as a Reserve with the rank of Colonel (1950-1983). In 1985, he earned a Litt. D. from Hellenic College / Holy Cross Orthodox Seminary.

Founder of the Center for Byzantine and Modern Greek Studies at Oueens College in 1974, serving as its Director, 1976–2002.

Professor of Political Science, Queens College and Graduate School, City University of New York, 1970-2002.

Program Director, Seminar on the Modern Greek State, Center for European Studies, The Graduate Center, City University of New York, 1976-94 and City University of New York Academy of Humanities & Sciences, 1994-2002.

Founder and Coeditor and frequent contributor of the Journal of Modern Hellenism, 1984-2002.
